2. The following aggrieved bidders or their representatives attended the meeting on behalf of their respective firms/companies (attendance of meeting attached).

i. M/s Revive Pharmakon

ii. M/s Shazeb Pharmaceutical Industries Ltd.

3. The grievance filed by **M/s Revive Pharmakon** against technical acceptance of **M/s Shazeb Pharmaceutical Industries Ltd.** was discussed. The representative of M/s Revive Pharmakon presented that M/s Shazeb Pharmaceutical Industries Ltd. was blacklisted by Myo Hospital Lahore in F.Y. 2018-19 due to non-supply and firm's past performance of last five years regarding supplies also remained very poor especially in Sh. Zayed Hospital Rahim Yar Khan. The representative requested to reject the bid submitted by M/s Shazeb Pharmaceutical to avoid any problems regarding supplies in case of purchase order issued to the same. The chairman noted that as per documents attached with the grievance, the blacklisting was for one year only and debarment was also for Myo Hospital Lahore also however for the sake of justice committee will decide the matter after hearing the stance of M/s Shazeb Pharmaceutical.


The representative of M/s Shazeb Pharmaceutical was also called and inquired about the current status of complaints against the firm. The representative claimed that all the supplies are smooth now and assured the committee to ensure supplies in case of award.

**Decision:** The chairman after discussion with the members, required the representative of M/s Shazeb Pharmaceutical to submit an undertaking on judicial paper that currently firm is not facing blacklisting by any govt. institution and the firm will ensure supplies in case of award. Hence the appeal lodged by M/s Revive Pharmakon was disposed of / rejected unanimously.


4. No one attended the meeting on behalf of M/s Frontier Dextrose Limited. However, the grievance filed by the firm was discussed in detail and the chairman after discussion with the members of the committee concluded the following.

Decision: As both invalid documents (Drug Manufacturing License & cGMP Certificate) attached with the bid pertain to inspection & certification by Drug Regulatory Authority of Pakistan (DRAP) and reflect the current manufacturing status/practices of the manufacturer in terms of SOPs and rules framed by Drug Regulatory Authority of Pakistan (DRAP) and absence of valid corticates is also non-compliance of compulsory parameters of evaluation criteria so the committee unanimously decided to uphold the decision of Technical Evaluation Committee and rejected the appeal of M/s Frontier Dextrose Ltd.


5. The meeting ended by vote of thanks by the Chairman Grievances Committee.


