- Pre-bid meeting shall be held on **10-10-2022** at 11:30AM in the Conference Room of CPEIC, Multan. All interested bidders are requested to submit their reservation, if any, in writing which will be discussed in the meeting for appropriate decision. The reservation must be submitted two days before the pre-bid meeting.
- All taxes will be applicable as per Government rules.
